# WHAT THIS MEANS FOR YOU

## **COMMUNICATE YOUR PLAN TO OCCUPANTS**

You are required to communicate their health & safety measures to occupants. This includes providing information on cleaning frequency and scope.

## **DISINFECTION BETWEEN USES**

Any shared items or spaces need to be disinfected between uses. You will need a plan to deep clean desks, rooms and common spaces for students and staff.

## **HAND WASHING AND SANITATION STATIONS**

You will need to provide ample sanitation stations throughout every space for employees to use as well as ways to ensure these stations are full.

## **DOCUMENTING CLEANING & SANITATION EFFORTS**

Should a COVID case be identified or inspection be needed, you will be required to provide proof of compliance with health & safety standards including adherence to air quality and cleaning protocols.
